Plan Review Skills examines the soft skills, or nontechnical traits and behaviors, that enhance the plan reviewer's ability to interact and collaborate with other stakeholders in the built environment. This course is in two parts. Part one covers decision making. problem solving, professionalism, integrity, honesty and time management with the goal of fostering the public trust. Part two covers elements of a plan review and systematic approaches to the plan review process to ensure success. This Plan Review Skills class will also help Permit Techs to better understand the process and explain why certain documents required at permit application submittal.

### **Wall Bracing and Truss Bracing**

"MN 1300 and Wall Bracing," is designed to provide attendees with a comprehensive understanding of critical aspects of building codes and construction practices in Minnesota. It will cover essential topics such as identifying your audience and customer, navigating Minnesota Rules 1300-1303, and the intricacies of permits and applications. The course will also delve into the Minnesota Energy Code, inspection and correspondence records, and key chapter 3 building planning highlights. A significant portion of the course will be dedicated to a practical approach to wall bracing, including a review of its intent and purpose, identification of requirements needed for plan review and inspections as well as addressing common corrections encountered in 2025, emphasizing communication strategies to avoid recurring issues.

#### 2024 IBC Means of Egress

Session 632

This seminar addresses numerous provisions in Chapter 10 of the IBC pertaining to establishing a compliant means of egress system in buildings. The course is intended to assist designers, plan reviewers, inspectors and code officials in applying the concepts and applications of both the egress design provisions and the egress component requirements. General topics of discussion include the determination of occupant loads, exit access design, including egress distribution, common path of egress travel, corridors, egress illumination and exit signs, and exit components, such as interior exit stairways, exit passageways and horizontal exits.

These components, defined in Chapter 2, are considered as highlevel elements that provide a considerable degree of occupant protection within the means of egress system. The exit discharge provisions will also be discussed. Specific topics include interior exit stairways, exit passageways, horizontal exits and exterior exit stairways.

Based on the provisions of IBC Section 508, this seminar addresses those special requirements applicable to buildings containing two or more occupancy classifications. The three mixed-occupancy options are presented along with examples and exercises that illustrate the proper application of the provisions. Specific topics include:

## Podium Type Buildings-Issues and Solutions Session 641

Podium type buildings are becoming more popular across the country. They are unique buildings with many different code requirements. This seminar will provide an overview of the specific requirements for these types of buildings and how to apply the building code to the design, construction and inspections. Subjects will include type of construction, building height and area, means of egress and much more. Session 644

This seminar will address the 2024 International Building Code® (IBC) requirements applicable to design and construction of assembly spaces. It will address the differences between the various Group A occupancies and how assembly uses may also fit within the business or educational occupancy classifications. The seminar will cover the unique aspects of the code related to assembly uses including the stage and platform requirements of Section 410, the ICC 300 Standard for Bleachers, Folding and Telescopic Seating, and Grandstands, the special egress provisions of Section 1030, along with the special amusement areas and motion picture projection room requirements from Chapter 4. The discussion will also include the unique IBC criteria applicable to fire protection and building size issues in assembly buildings. During this seminar, participants will listen to a lecture, discuss examples and participate in activities that pertain to the course content.

#### 2024 IBC Transition from the 2018 IBC

Session 651 W

This seminar will assist participants in implementing the transition from the 2018 IBC to the 2024 IBC. It will include relevant changes in both the 2021 and 2024 editions. This interactive training will focus on the intent and application of the new and revised requirements with an emphasis on fire- and life-safety provisions. #### 2024 IRC Transition from the 2018 IRC

This seminar reviews and analyzes selected significant changes from the 2018 IRC to the 2024 IRC. It assists code users in identifying the specific code changes that have occurred, and more importantly, understanding the reason behind the change. #### 2024 IRC Decks, What's New

Session 653

Since the 2015 IRC, Section R507 for decks has been growing and changing. In the 2024 edition, a nearly complete package of prescriptive structural design codes are provided. This class will cover the new and changed codes in the 2024 IRC for deck construction, and some significant ones from the 2021 edition. Like decks, porch roofs are often considered easy construction and are often attempted by new contractors or weekend warrior homeowners. However, the truth is quite the contrary. Porch roofs require significant evaluation depending on the extreme variety of their design. This class reviews the code application of these projects from the foundation to the roofing for both designers and reviewers.

#### **2024 IBC Care Facilities**

Session 655

This seminar will address provisions in the 2024 International Building Code®(IBC) and referenced standards relating to the design and construction of care facilities, such as medical care, custodial care, ambulatory care and day care facilities. It will focus on the specific decision-making needed to apply the provisions appropriately by highlighting the differences between the various types of care activities. The seminar will include a discussion on how the length of stay, number of care recipients, degree of care and capability/incapability of self-preservation all relate to the occupancy classification and resultant code requirements. Smoke compartments, dwelling and sleeping unit separations, incidental use separations and other special conditions provisions are also addressed. Unique provisions will be highlighted in the areas of accessibility, type of construction, fire protection, means of egress and interior finishes. During this seminar, participants will listen to lecture, discuss examples and participate in activities that pertain to applying sections of the IBC to care facilities.

#### **Fire Sprinkler Systems: Sprinkler Equipment** Session 661

Examining fire sprinkler system manufacturer specification, bulletins, technical data sheets, or "cut sheets" are an important part of being a fire sprinkler system inspector. Fire sprinkler systems are installed according to the International Building Code® (IBC) and one of the two US model fire codes (International Fire Code® (IFC), or NFPA 1 Fire Code) and their referenced standards (NFPA 13), but manufacturers have specific installation requirements for their listed products adding to the minimum requirements. This course will review specific cut sheets of sprinklers, piping, valves and more to provide an efficient and thorough method of incorporating the review of these documents.

#### Fire Sprinkler System Plan Review

Examining fire sprinkler shop drawings, cut sheets and hydraulic calculations is a primary duty of the authority having jurisdiction. This course will provide a method of reviewing plans and other fire sprinkler documents that is efficient and thorough. Attendees will learn what documents to accept to start a review, and how to have confidence while reviewing hydraulic calculations. This course applies to current codes and the standards to fire sprinkler systems from the initial site plan review, through the construction documents, to the as-built drawings. Significant time on how to effectively communicate deficiencies to the design professional. Students will receive a handout that provides detailed checklists with expert commentary that is useful to the fire sprinkler plan review for years to come.

#### Session 663 **Standpipes for Fire Protection**

This one-day program provides participants with comprehensive knowledge of the design, layout and installation of standpipe systems in accordance with NFPA 14. The seminar will also include an in-depth review of the scoping and installation requirements outlined in the International Building Code® (IBC). Through engaging discussions and activities, participants will explore topics such as system pressures, challenges in tall buildings, requirements for horizontal standpipes, and acceptance testing criteria for standpipe systems.

## **Rough and Final Inspections** of Sprinkler Systems

Session 664

This one-day seminar provides attendees with vital information on how to conduct the field inspections for new fire sprinkler and standpipe systems. Fire sprinkler systems are installed in stages, and inspections are required before commencing the next stage. The codes require periodic on-site inspections as the work progresses, to be installed according to the approved construction documents. This work must be inspected and approved before being covered or before the system is commissioned. This course points to the visual and physical inspection requirements of the latest codes and standards.

## **AM: Firestop Systems**

Session 665

This presentation will provide a detailed review of how throughand-membrane penetrations in fire-resistance-rated assemblies are protected following the Design, Installation, Inspection and Maintenance (DIIM) concept. It includes an in-depth review of code requirements, testing procedures, what materials and components make up a firestop system, how to use the UL Product IQ online directory to locate code compliant systems, and how to insure that the firestop system is installed as a "complete assembly."

# PM: Protect your Openings Fire Door and Fire Window

This program provides a detailed look at the requirements of Chapter 7 of the 2018 International Building Code® (IBC) for protection of fire door and fire window assemblies. For each topic, the program includes a discussion of code requirements, the referenced standards, the testing process, the available methods of demonstrating code compliance, the installation process and the inspection process. In addition, it will cover the maintenance requirements for the International Fire Code® (IFC) and NFPA 80.
